

# Privacy Policy

This Privacy Policy ("Policy") applies to newcryptoinsight.com, and Alpha Search LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include newcryptoinsight.com. The Company's website is a educational and informational site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Race
- Device Type, Website Usage Data

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through the Company's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us.
